

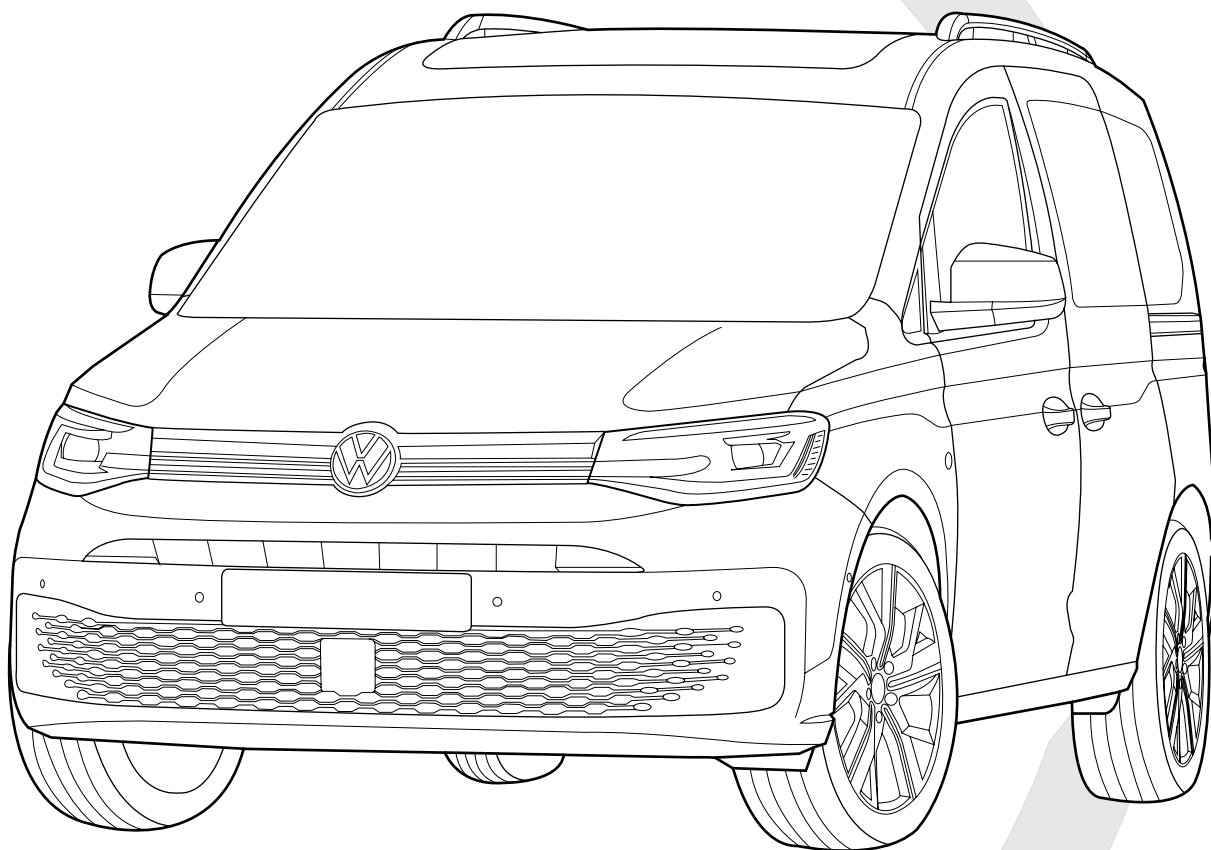

NL Belangrijke raadgevingen

Montage

- Voor de montage moet de trekhaak eerst op het voertuig gepresenteerd worden.

De belasting van een aanhangwagen en van een accessoire dat op de koppelingskogel wordt voorzien, zijn anders van aard. Voor beiden kunnen verschillende limieten van toepassing zijn. Hiervoor verwijzen we naar het instructieboekje van de wagen of naar uw concessiehouder.

FR Recommandations importantes

Montage

- Présenter l'attelage sous le véhicule avant d'effectuer le montage.

La charge d'une remorque ou d'un accessoire prévue sur la boule d'attelage, est de nature diverse. Pour ces deux éléments, il peut y avoir des limites d'utilisation. Nous vous recommandons de vous référer à votre livret d'instructions ou de vous renseigner chez votre concessionnaire.

EN General instructions

Fitting

- Present the towbar under the car first to check if all points are right.

The load of a trailer and of an accessory fitted on the towing ball are of a different nature. Different limits may apply to both. For this matter, we refer to the instruction manual of the vehicle or we advise you to contact your concessionaire.

DE Wichtige ratschläge

Montage

- Erst die Anhängerkupplung und das Fahrzeug kontrollieren, danach montieren.

Die Belastung eines Anhängers und eines Zubehörs, die man auf einer Kupplungskugel voraussieht, ist wesentlich anders. Für beide gilt, dass diese unterschiedlich begrenzt sein können. Deswegen möchten wir verweisen auf die Bedienungsanleitung des Fahrzeugs oder auf Ihren Vertragshändler.

ES Instrucciones generales

Montaje

- Presentar el enganche debajo del vehículo antes de realizar el montaje.

- Præsenter trækstangen under bilen først for at kontrollere, om alle punkter er rigtige.

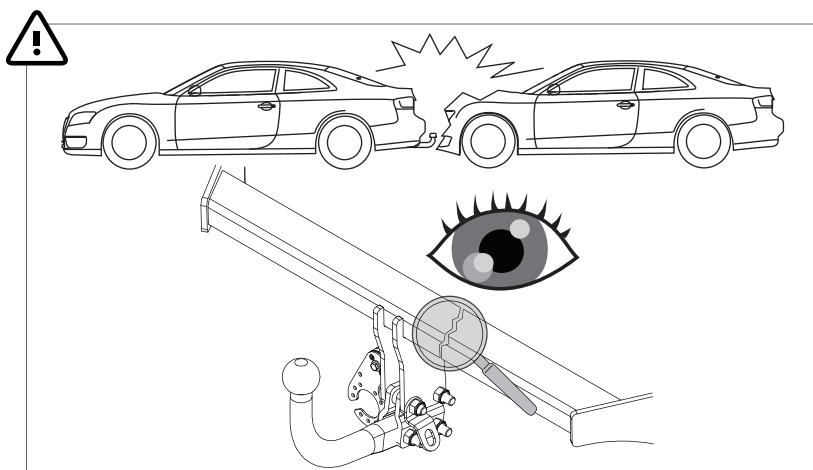

- In primo luogo, presentare la struttura sotto l'automobile per verificare che tutti i punti di attacco coincidano.

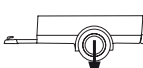

Per facilitare il controllo della compatibilità del dispositivo di traino sul veicolo, è opportuno confrontare le masse riportate sulla carta di circolazione del veicolo con le masse di riferimento sotto riportate (**T** ed **C**):

To simplify checking the compatibility of the towing device on the vehicle, it is advisable to compare the masses shown on the vehicle registration certificate with the reference masses shown below (T and C):

T = Massa complessiva del veicolo in kg Total vehicle mass in kg
C = Massa rimorchiabile del veicolo in kg Towable mass of the vehicle in kg

Massa complessiva del veicolo, desunta dalla carta di circolazione (**F2**) in kg
Total mass of the vehicle, taken from the registration certificate (F2)

deve essere inferiore od uguale a quella di riferimento **T** (= kg)
must be less than or equal to the reference T

Massa rimorchiabile del veicolo, desunta dalla carta di circolazione (**01**) in kg
Towable mass of the vehicle, taken from the registration certificate (01)

deve essere inferiore od uguale a quella di riferimento **C** (= kg)
must be less than or equal to the reference C

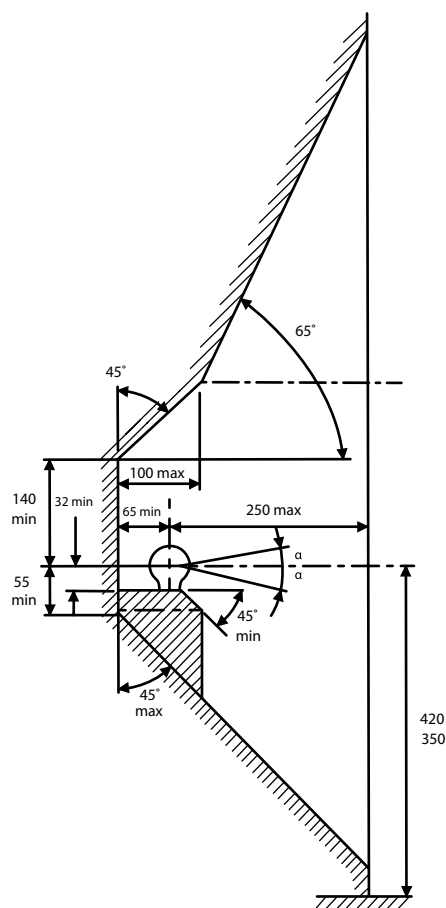

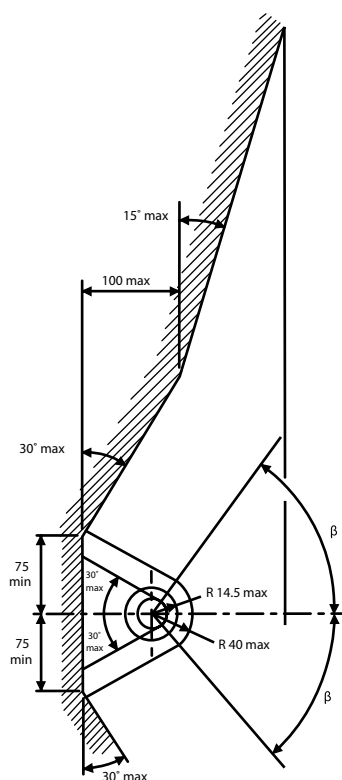
